All 4-Year Olds & under that pass through the ring are eligible for the LG Sale Graduate Futurity Barrel Race. The Graduate Futurity is for horse's 5-years & under. Horses are only eligible to enter during their Futurity year.

□ Session 1 Futurity Prospect (\$490 consignment fee + 8% - Color Photos Required – Yearlings, 2, 3 & 4 Year Olds that have not been entered)
□ Session 2 Performance (\$490 consignment fee + 8% - Color Photos Required – All ages currently performing or eligible to perform immediately)

Horses will be housed indoors, on dirt floors, & consignment fee includes stall and 2 bags of shavings.
